SUPPORT A FRIEND:

If a friend discloses an incident of sexual harassment, sexual assault, dating violence, or stalking:

- Give them your full attention and listen without judgement.
- Identify any immediate safety concerns; call 911 if needed.
- Acknowledge the difficulty it takes to disclose "Thank you for telling me" is a great way to start.
- Encourage them to contact on-campus resources, including a VPVA at 848-932-1181 (available 24/7).
- Remind them that the incident can also be reported to the Title IX Office and/or local law enforcement, such as RUPD.
- Avoid giving advice. Allow your friend to make their own decision on how to proceed.
- Ask for help. You do not have to handle this alone. The Title IX Office and VPVA and are here to help you too.
